REGULATIONS

Applicable to exhibitors 09-11 April

- 1) The Norwegian Ham Meeting 2010 in LetoHallen is arranged by the Gardermoen group of NRRL during the period 09-11 April 2010.
- 2) Exhibitors should be in attendance at their stands when the exhibition is open to the public.
- 3) Further letting of stands is not allowed.
- 4) Posters and other advertisements cannot be erected or distributed at stands or in the car park without prior agreement and permission from the Arrangement Committee. Free samples and other advertising materials may only be distributed at exhibitors own stands.
- 5) Exhibitors must obtain permission from the Arrangement Committee if wishing to make use of demonstrations, displays/shows, distribution of free samples, sound, film, and the like. Use of sound enhancers or other kinds of microphones are not allowed due to probable disturbance to other exhibitors. These regulations must be strictly adhered to.
- 6) Exhibitors are legally and economically responsible to LetoHallen for any harm or damage themselves, their assistants or products cause or inflict on properties, materials and people. Particular care and caution must be given to the floor-covering.
- 7) Exhibitors are obliged to adhere to both general and specific regulations and security measures which the Committee, the local Municipality, Police, Fire Department and Health and Security authorities have imposed.
- 8) According to LetoHallen regulations exhibitors are not permitted to sell food, non-alcoholic or alcoholic beverages either inside or outside the building.
- 9) Exhibitors must provide all transport, mounting, dismantling, and packing of their equipment. Exhibitor's property and materials must be labelled with the exhibitor's name.
- 10) When the exhibition is dismantled stands should be returned free of materials, decorations and so on. Exhibitors who do not comply will be asked to cover any expenses incurred by the Arrangement Committee in this connection.
- 11) General security is enforced during opening times by the Arrangement Committee and LetoHall has a 24 hour alarm surveillance system. The Arrangement Committee however, does not take responsibility for exhibited goods, equipment and personal possessions. It is expected that exhibitors obtain any necessary insurance coverage themselves. The exhibition hall is open to exhibitors from 10 o'clock on 9 April.
- 12) On 11 April exhibitors' stands must be cleared by 10 pm at the latest. Dismantling cannot commence until after the Hall is closed to the public, however. Fines will be imposed if exhibitors disregard this regulation.
- 13) If the exhibition is cancelled or hindered due to circumstances beyond the Arrangement Committee's control such as 'Force Majeure', fire, flooding, strikes, lockout, municipal activity, cuts in electricity, water, heating, telephone etc, exhibitors cannot claim any form of compensation from the Arrangement Committee.

4. Registration is legally binding. Withdrawals due to 'Force Majeure' or other reasons must be in writing and sent as a recommended letter no later than 28 February.
In the event of the above, exhibitors pay 20% of the agreed cost.
For withdrawals received after 11 March, exhibitors pay the agreed cost in full.
5. If an exhibitor fails to attend, withdraws, or commits a breach of contract, costs remain the responsibility of the exhibitor even though the area/stand is re-allocated.
6. The Arrangement Committee reserves the right to allocate areas and positioning of exhibitors.
7. The signee declares to have read carefully all the points of the above Contract and Regulations (080110), and is in agreement with these. If any point is breached, the exhibitor will be economically responsible
8. **Only written agreements are valid.**
